


Item Update—Membership



- Increased PAC reach by PAC Attack happening on Friday of Spring conference during BOE session.—This did not work well.


<u>Item Update—Volunteer</u>:

<u>Item Update—Conference:</u>

- Sent out email survey to members who have not attended a NCCA conference in 2 years.
- Reached out to speakers of Spring Conference for blogs, etc to keep conversation going and we will send targeted email to conference attendees after conference. Many speakers (Hoag, Plasker & Lesch) even did Coffee & Chiropractics for us. Will do same thing for Fall convention
- Featured speakers on Facebook to increase reach.
- Researching streaming the August 25th Opioid event as a test run for potential conference engagement
- Increase family involvement is ongoing. Will have kid zone area once again at Fall Convention.
- We have different options available to stream including FB streaming which we have utilized at the last Fall conference and the Opioid Summit. Many speakers will not give permission for their presentation to be distributed. For example Bill Moreau for the 2019 Spring Conference has agreed to be livestreamed during the event but we must remove the video once the event is over. My conclusion and course of action is to continue to use cost effective choices of streaming such as FB until there is a strategy/need/demand and availabitiy of content to be streamed through a platform. We have the capability with the new platform when we are ready to do that.

<u>Item Update—NC BOE:</u>

- Part IV exam was on NC BOE agenda 1/26. Committee action required and will be discussed again at 4/27 meeting
- CEU approval was discussed at 1/26 NC BOE meeting. Philosophy will be approved but the board in discussion was very adamant that practice management would not be approved.
